3 **PIN Request**  
The Tax Collector will mail a PIN code to the last known address for the assessee of record. To enable advanced features, this PIN must be submitted via the My Properties page or the Account Summary page.

This will prompt the Tax Collector's Office to confirm if the parcel is deemed to be yours. You may exit the website or browse for other properties. Once approved, the Tax Collector's Office will send you a letter in the mail with a pin number. The next time you log in, there will be an area for you to enter your pin number in the provided area.
