V. NEW BUSINESS

A. School District Superintendents Welcome

Chief Keene welcomed the San Mateo County School District Superintendent's and shared that he would like to reinvite representation from each school district in the county to bring back ongoing collaboration and communication regarding early intervention measures taking place at the local level. It would be great to have a broader discussion on what diversion and prevention work currently looks like outside of Probation and pull resources together. The goal is to prevent young people from moving deeper into the system by helping them and their families early in the process.

- ➤ David Norris shared that the Menlo Park Police Department is partnering with Atherton and East Palo Alto to develop protocols to provide early intervention in cities within the jurisdiction of Menlo-Atherton High School.
- > Susan Manheimer added that we all need to be intentional with intervention services for it to work.

B. Comments & Updates

Chief Keene discussed the Juvenile Services and Institutions Data from April through June 2024.

- ➤ The youth in the system come from the same major cities: Daly City, East Palo Alto, Redwood City, and San Mateo.
- For youth in Juvenile Hall, the average length of stay has increased dramatically to 57 days, 92% of the population are felony offenses.

C. Budget Update

Chief Keene shared that there are no major updates. All funding streams remain the same.

> Still no update on the funding associated with the secure track SB823 youth.
